Nordic Model Now! is a secular feminist grassroots women’s group based in the UK. We formed in March 2016 with the specific aims of campaigning for the abolition of prostitution and related practices (such as lap-dancing, pornography and surrogacy) and for the introduction and effective implementation of the Nordic Model approach to prostitution.

We are a not-for-profit organisation and as initially our income was small, we operated as an unincorporated association until 2022. We are now registered as a not-for-profit company limited by guarantee. (Company name: Nordic Model Now Limited. Company number: 14269536).

Our main source of income is donations, mostly small, from individuals who support us, along with ticket sales and sales of merchandise (booklets, badges, etc.). We are grateful for every single contribution. We are also grateful to all the members of the group – all of whom are unpaid volunteers, who not only donate their time, skills and energy, but also whenever possible pay their own expenses associated with the campaign. And we are grateful to all the others who have helped the campaign in a myriad of different ways.
